## **UPDATE: UOITFA** continues negotiations into the summer

Negotiations have had a bit of a break--due to several negotiators, on both sides, being at various conferences, etc. Negotiations resumed on June 18.

We have made some tentative progress over the last few months...; but it is clear that we will have to work hard for every clause and concession. Priority one has been to move the materials on Tenure/Review/ Promotion properly into the contract, and thereby allowing the process to become grievable. The alternative is having references in the contract to external

policies, thereby not allowing for the process to be grievable. There's been some movement, but so far, only minimal movement.

As reported in recent meetings, management is clearly favouring a minimalist approach to the contract. We would greatly value your show of support (e.g. by email or in person at FA meetings), to demonstrate to the team what are the most important issues facing our membership. Your support, by way of input and participation, are key to these negotiations.

## UOITTA Express CAUT calls for Minister Goodyear's resignation over political interference and attack on academic freedom

For immediate release (Ottawa, June 10, 2009) The organization representing more than 65,000 academic and general staff at 121 universities and colleges across Canada is calling for the resignation of Minister of State for Science and Technology Gary Goodyear following his unprecedented efforts to interfere with funding for a major academic conference.

CAUT has learned that Goodyear telephoned the president of the Social Sciences and Humanities Research Council (SSHRC) to ask him to reconsider a peerreviewed decision to fund an academic conference called "Israel/ Palestine: Mapping models of statehood and prospects for peace" being held at York University later this month.

"It's unprecedented for a minister – let alone a minister from the department that funds the granting councils – to intervene personally with a granting council president to suggest that he review funding for an academic conference," said CAUT executive director James Turk. "This kind of direct political interference in a funding decision made through an independent, peerreviewed process is unacceptable and sets a very dangerous precedent."

Turk said that a principal role of universities in democratic societies is to allow a full, open debate of controversial issues.

"For a minister to intervene in an effort to derail an academic conference on behalf of special interest groups is simply unacceptable, and compromises the integrity and public purpose of universities," said Turk.

"That's precisely what happened here – when you are the minister from the department that funds the granting councils, and you call the president of a granting council to ask him to reconsider funding, the message is very clear."

## Membership Renewal – Payroll Deduction Available

Since Collective Agreement negotiations are not completed yet to automatically renew your UOITFA membership, and since your membership expires on June 30, 2009, the process for renewing your association with UOITFA is now underway. Please complete the **2009 – 2010 UOITFA Renewal Application** form and return it to me at the address below or as an email attachment.

Payroll deduction is now available. If you would prefer to have your Association dues deducted at source, please complete the **2009** – **2010 Payroll Deduction Authori**zation form and ensure that it has been witnessed. The appropriate membership fees, based on your rank, will be deducted over ten (10) pay periods from September 2009 to June 2010 inclusive. This will make your life (and mine!) easier since neither of us will be concerned about cheques, deposits, etc.

from Clark University.

Her research focuses on the way we use the Internet to advocate for social change. The primary focus of her dissertation research was on the gendered discourse and personal narratives of cyberactivist women, or cyberconduits. She examined women's weblogs from Iran, Iraq, and Afghanistan to understand the role the Internet played in these women's everyday lives. Weblogs mirror the Internet's culture of self- disclosure and community, are designed for audiences, and provide a space for established voices to be heard while creating spaces for new voices. These new voices, or cyberconduits, are cyberfeminists who

advocate for social justice on a local level, and act as knowledge conduits by using digital media and technology such as blogging to connect with activists on a global scale. As a communication scholar, Pierce focuses on the ways we integrate communication in our everyday lives and how these, in turn, globalize our communication strategies. She has published in the areas of communication and the environment, and in the gendered politics of ICT. New interests include issues surrounding Communities of Practice, media ecology, and the political rhetoric of science.
